paid in the event of canceling a rental.

Responsible Party agrees that full compensation is due if site location is not
suitable for equipment and no alternative is reserved, as this is the sole
responsibility of the Responsible Party.

Responsible Party agrees to be responsible for any damage to Kokopelli
Adventures equipment, if damage is caused by Responsible Party.

The Responsible Party agrees that that any person(s) who use Kokopelli
Adventures equipment does so at their own risk and that if any injury occurs to the
person(s) using said equipment Kokopelli Adventures, its employees, officers,
directors, shareholders, agents, successors and assigns shall not be held liable for
any such injuries and /or resulting damage and further shall indemnify Kokopelli
